From June10, 2010-October 29, 2010, change orders will only be issued in part or in whole for a sum not to exceed \$25,000. Any cumulative change orders or single change order exceeding \$25,000 will either be presented to the school board at a regular or special meeting or Dr. Miller will make a decision after securing input from Board members with ratification at the following Board meeting. If the amount is over \$25,000, Bob Clendennen will direct Dr. Miller as to schedule a special meeting or to make an administrative decision as to how to proceed.
