This change is necessary in order to install the fixtures, which are suspended from the ceiling, as high as possible. The metal stems are a fixed length and do not allow any adjustment to the suspended height. The ceiling in this room needed to be installed lower than anticipated given interferences with structure and utilities, which would have resulted in the light fixtures being too low. The change will allow the fixtures to be installed higher above the floor than with the stems. (Exhibit E)
