## Highland Middle School Renovation Project by Dan Engen, VEBH, Architect

Approval is recommended for the process to approve following change orders for the Highland Renovation Project:
Change orders for the Highland Middle School project will be approved by the Buildings and Grounds committee or designees for change orders up to $\$ 15,000$ per item, per Contract.
