# Roll Call Vote: 9 – Yes; 0 – No; Motion Carried

Motion (Mr. Barsottini, seconded by Mr. Oswald) for Resolutions A-H detailing the District's tax levies, tax collectors, tax collectors, and compensation rates for tax collectors.

A. Real Estate Levy: RESOLVED, that for the purpose of providing funds for payment of salaries to the teaching and supervisory staff, rentals due to the Authority and sinking fund charges on building projects approved by the Department of Education, with the balance, if any, to be used for the purpose of providing funds generally for the ensuing Fiscal Year in accordance with the foregoing budget, the Board of School Directors does hereby levy and impose a tax upon real estate for the year 2009-2010 at a rate of 51.26 mills on the assessed valuation of the property in the District's municipalities in Beaver County and at a rate of 17.6 mills on the assessed valuation of the property in the Enon Valley Borough in Lawrence County or \$5.13 per \$100 of assessed valuation in the District's municipalities in Beaver County and \$1.76 per \$100 of assessed valuation in the Enon Valley Borough of Lawrence County.

- B. School Code Per Capita Tax--Section 679: RESOLVED, that for the purpose of providing funds for the ensuing Fiscal Year, in accordance with the foregoing budget and pursuant to the authority granted under Section 679 of the Public School Code of 1949, as amended, the Board of School Directors does hereby levy and impose a Per Capita Tax of \$5 on each resident or inhabitant of said School District 18 years of age or over. The determination of taxables and the assessment, collection and enforcement of the tax shall in all respects conform to the provisions of the Act 511 Per Capita Resolution adopted heretofore and continuing in force except where the latter is inconsistent with and cannot be reconciled with the provisions of the Public School Code, as amended.
- C. Refer to the attached resolution for approval to adopt a new tax installment Payment plan.
- D. Commission for Collection of School Code Per Capita Tax: RESOLVED, that during the Fiscal Year commencing July 1, 2009, a four percent commission shall be paid to all Real Estate Tax Collectors in the Blackhawk School District for all School Code Per Capita Tax (Section 679) collections based on the 2009 Per Capita Tax List.
- E. Appointment of Delinquent School Code Per Capita Tax Collector and Fixing Compensation: RESOLVED, that the Berkheimer Agency, Beaver Falls, PA, and Sharp Collections of Sharpsville, PA are hereby appointed the collection agencies during the Fiscal Year commencing July 1, 2009, for delinquent School Code Per Capita Taxes due to the Blackhawk School District and which are returned to the agency for further collection, and for such service shall be paid as follows: (a) Per Capita Tax--There will be no charge to the School District and costs will be charged to the delinquent taxpayer. (b) Earned Income Tax--Twenty percent (20%) of the gross collections will be charged to the School District and cost will be charged to the delinquent taxpayer.
- F. Appointment of Earned Income, Occupation Privilege, and Mechanical Devices Tax Collectors and Fixing Compensation: RESOLVED, that the following persons and agency be, and they are, hereby, appointed for the year 2009-2010 or until the election and qualification of their successors, collectors of the Earned Income Tax, the Occupation Privilege Tax, and the Mechanical Devices Tax imposed under Act 511 within the respective municipalities set forth opposite their names:

Darlington Borough - Centax

RESOLVED FURTHER, that the commissions of said collectors be fixed at a rate of 3.25 percent on the first \$300,000 of Earned Income Taxes collected, 2 percent on

all Earned Income Taxes above \$300,000, at a rate of 4 percent of Occupational Privilege Taxes collected, and at a rate of 5 percent of Mechanical Device Taxes collected.

- G. Appointment of Amusement Tax Collector: RESOLVED, that the Business Manager be, and hereby is, appointed Collector in the entire Blackhawk School District for the Amusement Tax imposed, in accordance with Act 511, for the 2009 2010 Fiscal Year.
- H. Appointment of Act 511 Per Capita Tax Collectors and Fixing Compensation: RESOLVED, that the elected Real Estate Tax Collector in each municipal component of the School District be, and he/she is, hereby appointed Tax Collector of the Act 511 Per Capita Tax in his/her respective municipality for the Fiscal Year commencing July 1, 2009, or until the election and qualification of a successor.

Motion (Mr. Barsottini, seconded by Mrs. Lambert) for Authorization to Invest General Fund Receipts: RESOLVED, that the Treasurer, in consultation with the Superintendent and the Board Secretary, be authorized to make temporary investments of School District funds from time to time during the 2009-2010 Fiscal Year in accordance with the provisions of Section 440.1 of the PA School Code of 1949, as amended.

Motion (Mr. Barsottoni, seconded by Mr. Fitzgerald) for the following Depository Resolution: It is recommended that First Commonwealth Bank, ESB Bank, Citizens Bank, PA Treasurer's Invest Program, Pittsburgh National Bank, Pennsylvania Local Government Investment Trust (PLGIT), and the Pennsylvania School District Liquid Asset Fund be designated as the depositories for the General Fund of the Blackhawk School District during the 2009-2010 Fiscal Year. It is further recommended that the Chippewa branches of Citizens Bank and ESB Bank be designated as the depositories for the Blackhawk High School Activity Accounts, The Highland Middle School Activity Accounts and the Blackhawk School District Athletic Account and that Chippewa branches of Citizens Bank and ESB Bank and Citizens Band and ESB Band be designated as the depositories for the Blackhawk Cafeteria Fund.
