#### **MEETING MINUTES**

#### **PRELIMINARY MATTERS**

Student Matt Young commented that Newsweek Magazine placed Blackhawk High School in the top 2,000 high schools in the nation at about number 1,575.

Mr. Jarrod McCowin congratulated the Board on the success of the Middle School project and low cost of change orders and reported that the Beaver County Times published an article saying the Blackhawk School District had the highest average for SAT scores in Beaver County.

Chippewa Police Chief Clint Berchtold commented on previous public comments about exterior lighting on District campuses and said lighting provides both safety and security and the cost of keeping lights on might well be exceeded by insurance deductibles for damages or injuries if they occurred.
